#### Theresa Golden - Assessor's Report

- 425 Change of Assessment notices were mailed the week of April 14, 2025.
- Informal meetings with the Assessor were scheduled the week of April 21 and April 28. A total of 13 informal appointments were scheduled.
- The Tentative Assessment Roll was filed on May 1, and 118 *Change of Taxable Status Notices* were mailed to property owners.
- Grievance Day will be held by appointment on Tuesday, June 3. To date two appointments are scheduled. A reminder letter was sent to all Board of Assessment Review members.
- The Equalization rate for the 2025 Assessment Roll is 70%.
- The Assessor is scheduled to attend a required Ethics Course in Liverpool on June 18.
- The Data Collector/Assessor Trainee will be attending Appraisal Course Number 2 at Cornell, the week of July 14.
- The Assessor's annual Disclosure Statement was filed with the Town Supervisor and Town Clerk, as required by Law.
- The Assessor's current term will expire on September 30, 2025. The Assessor will accept reappointment, but is not committing to the full 6 years.

Joel Plumley explained that several revisions were made in response to input from various boards and entities. One major change involved the townhouses, which have been rotated 90 degrees (as shown on the map) to improve snow removal and reduce the number of curb cuts along the new public road.

Additional visitor parking has been added; approximately 66 spaces distributed throughout that section. The apartment buildings have been relocated to the southern portion of the site, offering improved views and better integration with the surrounding single-family lots. These lots are now smaller, totaling approximately 53, and the overall housing density has been reduced from 585 units down to 537. As a result of this decreased density, the design of the pump station remains unchanged.

The updated LOI is available online under the "Notices" section of the website.

During the public hearing, residents expressed a range of opinions. Micron's environmental impact report, raising concerns about traffic, job creation, population growth, and pollution were issues raised. Others focused specifically on issues of traffic and housing density, particularly units per acre. There were also comments regarding school district capacity, with suggestions that a development of this scale should include sewer access extending to Palmer Elementary School.

He expressed his disappointment and apologized to the audience for what they must deal with at public meetings. He also expressed that the resident is the reason that people do not attend come to meetings.

# **Supervisor's Comments**

Supervisor Rode spoke regarding the following:

- Memorial Day Parade: Friday, May 30, 2025 5:30 PM with service at the Veteran's Monument after the parade
- Town Hall will begin summer hours on June 2<sup>nd</sup> from 8:30 AM to 4:30 PM M-Th and Fridays 8:30 AM to 1:30 PM
- Motion A will be tabled until the next meeting
- Highway Department Camera System Incident

**Supervisor Rode** informed the Board that the Highway Superintendent, Jonathan Butler, was not in attendance although he was asked to attend. He reported that Doyle Security had notified him that the Highway Department's security camera system had been deactivated.

**Supervisor Rode** confirmed upon investigation that the system had been tampered with and shut down. After reviewing the footage, he determined that Highway Superintendent Jonathan Butler was responsible for deactivating the system. He noted as Mr. Butler is an Elected Official, the matter falls outside the Town's personnel authority, and no formal disciplinary action can be taken.

**Supervisor Rode** stated the camera system was installed in October 2024 for reasons of safety, security, and insurance compliance. However, the installation was met with resistance from Highway Department staff. He added that, in light of this incident, he no longer has confidence in Mr. Butler's actions.

Councilor Kudarauskas expressed his disappointment and suggested that the camera system be secured against unauthorized access. He questioned whether the cameras were deactivated because there was something to hide. Supervisor Rode noted that he has been in ongoing discussions with Doyle Security throughout the week regarding the incident.

**Councilor Geraci** emphasized the importance of teamwork and expressed his disappointment with the actions taken.

**Councilor Moore** echoed the sentiment, stating that Mr. Butler's conduct was troubling and that the issue should have been openly discussed if there were concerns about the cameras. He emphasized that consequences are warranted and that, had this occurred in another setting or under an appointed position, more serious repercussions would likely have followed.

**Town Attorney David Herkala** clarified that, as an elected official, Mr. Butler is ultimately accountable to the voters. He noted that while limited state statutes exist to initiate proceedings against elected officials for malfeasance, such measures are rare. In contrast, appointed employees are subject to the Town's policies and disciplinary procedures.
