Comments:

Supervisor Wicks: *Is there anyone wishing to speak for or against the proposed local law?*

Fred Burtch of Plainville Road: *I am very familiar with that road as I had many accounts on that road for landscaping, and I understand what they're doing. This is something that other roads in Radisson have pretty much done in the past and this is just an extension of that. My question would be, and I know these guys are organized, and then they have the big yard sales. What about for say maybe the smaller developed community yard sales in the future? What if they wanted to have that, is that something they'd be able to approach the Board about too? Or to have just a temporary during it, if they had it during the same time each year?*

Supervisor Wicks: *The reason that we're doing this is because the roads get so congested that fire and police cannot get down the road. So that's what this is; probably because people were parking on both sides. So that's why we're amending this so you've got to be able to get the police and fire down there. This allows the Sheriff's Department or State Troopers to give tickets if people park there.*

Mr. Burtch: *I'm just trying to get a better understanding of it. And I agree with that. I noticed you know, maybe not in the summer but we also you know, have the similar type of issue on Brundage. When we have the illegal ones I would refer to as the ill-advised parking of the independent drivers. I know there's signage there and they don't pay attention to it - that doesn't allow the services like plowing of the road and stuff, so I'm in favor of that. I just wanted to get a little bit better understanding of it. Thank you.*

Town Board Comments

Supervisor's Comments

Supervisor Wicks spoke about the Volunteer Firefighter's Recruitment Day that TOL is hosting.

Ms. Falcone explained the details of the event, which will occur Saturday, April 22, 2023 from 10:00 AM to 2:00 PM at Town Hall. The following fire departments will be present: Belgium Cold Springs, Plainville, Cody, Seneca River, and North West. There will be food trucks on site as well. Ms. Falcone and President of Belgium Cold Springs FD, Catie Padalino, are working together to coordinate the event.

Department Head Reports

Town Attorney Rivizzigno spoke about the proposed Mills Road Water District and noted that essentially this is at the point of where the project will be "started over" from the beginning, beginning with the revision of the Map, Plan and Report, and it will follow Article 12(a) of Town Law.

Ken Svitak stated that the signs on Hayes Road should be done by April 1st, and he is going to be meeting with a representative from the County as to appropriate placement of the signs. He said they should be at least 200 feet apart.
