NOTICE IS HEREBY GIVEN that at a regular meeting held February 8, 2022, the Board of Fire Commissioners of the Plainville Fire District of Plainville, New York duly adopted a resolution, an abstract of which follows, which resolution is subject to mandatory referendum pursuant to Section 38(a) of the Local Finance Law and Section 179 of the Town Law, as amended from time to time.

Said resolution authorizes the district the issuance and sale of serial bond or bonds and a bond anticipation note or notes in anticipation of the issuance and sale of said serial bonds, in an amount not to exceed \$150,000.00. The proceeds from the sale of the obligations authorized in said resolution shall be used for the specific purpose of purchasing **eighteen (18) Scott Air Pak X3 Pro SCBA and incidental equipment**. The period of probable usefulness for said purpose is ten years. PROPOSITION #1: Shall the February 8, 2022 Bond Resolution passed by the Plainville Fire Commissioners authorizing the issuance of serial bonds a principal amount not to exceed \$150,000.00 of the Plainville Fire District pursuant to the Local Finance Law of the State of New York for the purpose of purchasing eighteen (18) Scott Air Pak X3 Pro SCBA and incidental equipment be approved?

All persons registered to vote within the territory of the fire district are eligible to vote on this proposition during this special election. **A public hearing on this matter will take place at 7:00pm on Tuesday, February 22, 2022** at the Plainville Fire Station Number 1, New York State Route 370, Plainville, New York 13137.

The period of probable usefulness for said purpose is ten years.
