A Regular Town Board meeting was held on October 4, 2018 at Lysander Town Hall, 8220 Loop Road, Baldwinsville, New York.

OTHERS PRESENT: Dina Falcone, Town Clerk; David Rahrle, Comptroller; Tony Burkinshaw, Parks and Recreation Supervisor; Tony Rivizzigno, Town Attorney; and several residents.

Supervisor Saraceni called the meeting to order at 7:00 PM with the Pledge to the Flag.

Supervisor Saraceni noted items that would be tabled and added to the agenda. During the work session these items were discussed. "A" will be tabled; "C" will be tabled, and "D" will be changed. "H" will be tabled, and "B" and "K" will be modified.

CITIZENS COMMENTS:

Kevin Rode of Greymoor Way asked a question about an agenda item "F", if it was in addition to the \$17K that was approved. **Supervisor Saraceni** said it is, because it was a change order in order to accommodate ADA requirements, which included 12 feet of additional wall, location of doors, windows and lights, and an emergency light, etc. It was estimated that the monthly rental income would be \$1,200 a month to net after five years at about \$50K.

Mr. Rode asked about item "I" and what the amount was as originally noted. **Mr. Burkinshaw** said it was a typo. The rate of pay is as indicated, \$13.00 per hour.

Mr. Rode mentioned the budget work sessions and asked about the status of the spray park and the timetable for building it. **Supervisor Saraceni** said New York State needs to officially approve the funding for the project. He said, "If for some reason at the eleventh hour the grant was voted down, then we wouldn't move forward with the project. We can't move forward until we get the official blessing from Albany on the grant." He said at this point it should happen this month, but the project cannot move forward. The Town is at a standstill right now from a municipal standpoint.

Mr. Rode asked about the septic system with regard to the park annexation, and asked if that was already budgeted for this year or next year. **Supervisor Saraceni** said he believed they were going to include that in the cost of the facility. **Mr. Burkinshaw** confirmed that that money was not budgeted this year.

Fred Burtch of Plainville Road mentioned the annexation. Supervisor Saraceni said the Board is not waiting on the Village's vote regarding the spray park/annexation. Mr. Burtch referenced the last meeting regarding contracting with the SPCA. He asked about the \$125 fee, and who would handle nuisance calls/barking dog calls. Supervisor Saraceni said the SPCA agreed to cover that for the same fee and that was an intermediate extension of the existing contract. The SPCA number is on the website and anyone who wants to report a dog wandering around should contact the SPCA. He asked about response time. He mentioned two dog control officers and asked about one of them not being on the agenda. Supervisor Saraceni said it was a personnel matter.

Jim Stirushnik of Dinglehole Road asked about the Citizens Committee information which would be made public. **Supervisor Saraceni** said each member's name and email address will be on the website and on the message board.

TOWN BOARD COMMENTS

Supervisor Saraceni mentioned the Canton Woods 40th Anniversary celebration. He noted the programming that they have, including Meals on Wheels, tax consulting, recreational activities, etc. He commended them on everything they do to make the lives of seniors better. He said it is a model of intermunicipal cooperation.

What the law has done is pressured or forced municipalities to live below their means which means infrastructure improvement and anything else exceeding the tax cap allows us to do.
